Inhalation.

6.1 Personal precautions, protective equipment and emergency procedures.

Eliminate possible ignition points and ventilate the area. No smoking. Avoid breathing fumes. Isolate the area and ensure adequate ventilation. 7.1 Precautions for safe handling.
